WHEREAS 'J&J LEATHER ENTERPRISES LTD' is desirous of availing dental facilities for the employees and their families.


TDCH agreed to provide dental services to the employees and their dependents of J&J LEATHER ENTERPRISES LTD, visiting TDCH.

5. TDCH at all times shall ensure to protect the confidentiality of the dental information and records of the staff and students. The confidential record shall not be shared with any outside agency whomsoever without prior written permission of 'J&J LEATHER ENTERPRISES LTD'
6. TDCH shall organize and conduct free dental camp and health education programs for the staff and their families regularly.
7. Dental treatment will be done at 10% discounted rates to the employees working in J&J LEATHER ENTERPRISES LTD and their families as and when required.

The agreement may be extended for further periods on the terms and conditions mutually agreed upon between the parties.

This agreement shall come into force from the date hereof. Either party may terminate this agreement upon 30 day's notice in writing to the other party, provided in the event of material



Each party represents that:

DURATION:


