Memorandum of Understanding (MOU)

The Memorandum of Understanding entered into this 22nd day of 2023 at Tagore Dental College and Hospital.

BETWEEN

Tagore Dental College was started in 2007 with the permission of Dental Council of India (DCI) under the Ministry of Health & Family Welfare, Government of India (GOI) for BDS course and with the affiliation with the state owned The TN Dr MGR Medical University. The recognition for BDS course was obtained in 2012. The MDS course in 4 postgraduate specialities was started with the permission of DCI and affiliation of the University in 2018.

#Right2face

The face is an integral part of a person's identity, not just in terms of appearance but also in terms of communication and social interaction. It is the primary means through which we express emotions and communicate with others. When a person is victimised by trauma, mucormycosis, Cancer, Congenital deformities or any disease that affects their face, it can be an incredibly challenging experience.

In recent times, the COVID-19 pandemic has claimed many lives globally. In addition to the loss of life, people have also suffered from a range of health complications, including the development of fungal infections like Mucormycosis. This disease can have severe effects on the face, destroying both its functionality and aesthetics.

Many people have been left with facial deformities because of trauma, cancer or congenital deformities that can be distressing and impact their ability to interact with others.

The #RIGHT2FACE movement aims to help those affected by such conditions by providing access to reconstructive surgery and rehabilitation. By doing so, it hopes to restore not just the functional and aesthetic aspects of the face, but also a person's sense of identity and ability to engage with the world.

In conclusion, every individual has the right to a good face and to face the world with confidence. The #RIGHT2FACE movement is an important step towards achieving this goal for those who have been victimised by trauma or disease.

Under #Right2face campaign we are arranging funds for unaffordable cases (eligibility will be decided after analysing the patients' socio-economic condition upon submission of relevant documents). Zoriox will design and manufacture the EZ-recon and will assist in the placing of the same. We have categorised the patients into two categories: Semi-affordable and affordable. The socio-economic status of the patient will be the deciding factor to categorise the patients into the two categories. In the semi-affordable cases, a part of the total cost will be paid by the patient, whereas the remaining cost will be funded, the arrangements for which will be made by zoriox. The cost of the implant and surgical cost to be paid by the patient will be decided based on the socio economic status of the patient. For the unaffordable cases, the implant cost will be totally funded whereas the surgical cost has to be borne by the patient. This is where we are eager to seek the help of TAGORE DENTAL COLLEGE AND HOSPITAL, to join hands with us by becoming a Surgical centre under #Right2face, for cases in your adjoining areas.

Now the parties are interested in working together in connection with the purpose which is described in the Memorandum. This Memorandum sets out the initial relationship between rights and responsibilities of each party. Each party respectively is expected to act in good faith in accordance with this memorandum.

Roles of Zoriox:

As part of this MOU Zoriox would provide its services to include the following:

- A. EZ-Recons - Patient specific implants will be designed and manufactured with the surgeons involved.
- B. Surgical assistance will be provided, if required.
- C. The company will provide value-added programs in creating awareness patient specific implants.
- D. Zoriox shall provide training programs on this technology for the students.
- E. All details shall be shared by both the parties (Tagore Dental College and Hospital and Zoriox) and Zoriox will be documenting all the details pertaining to every single case.

Roles of TAGORE DENTAL COLLEGE AND HOSPITAL:

- A. The Hospital will act as a surgical centre for all cases coming under #Right2face in and around its adjoining areas.
- B. The Institution is responsible for providing operation theatre facilities, pre surgical assessment and post-operative care.
- C. Recording of Case photographs and documents.
- D. Conduct research.
- E. Publish papers and articles.

Tenure of the MoU:

- a) The MOU will apply from the signed date and will continue to apply for a period of one year which can be renewed again with a fresh undertaking by a mutual understanding of both the parties.
- b) Either Party may terminate this Memorandum by providing 3-month prior notice in writing to the other Party.

Confidentiality

All information exchanged amongst the parties pursuant to this Memorandum shall be kept strictly confidential by the recipients except such disclosure required by Law.

Legally Non-Binding

This MoU is intended to represent the understandings of the parties and shall be regarded as a legally Non-binding document until a formal definitive agreement has been concluded by and executed between the parties.

Amendments

The Parties agree that any amendments made to this Agreement must be in writing and they must be signed by both Parties to this Agreement.

Dispute Resolution:

If a dispute or difference arises between the parties out of or in connection with this MOU, either party may give the other a written notice specifying the dispute or difference. Within ten days of the date of the notice, a person holding a position of senior management of each party must meet and undertake negotiations in good faith and on a without prejudice basis with a view to resolving the dispute or difference.

VARIATION:

The parties may agree to vary any of the requirements of this MOU in the future. Such agreement must be in writing and signed by both parties. This Document accurately reflects the understanding between the Party, on the signed date.
